**ORDINANCE NO. 17-933
PREVAILING WAGE ORDINANCE**

WHEREAS, the state of Illinois has enacted “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city, or any other public body, any political subdivision or by any one under contract for public works,” approved June 26, 1941, as amended, (820 ILCS 130/1 et.seq.); and

WHEREAS, the aforesaid Act requires that the MCHENRY COUNTY CONSERVATION DISTRICT, a conservation district organized and existing under the laws of the state of Illinois, of the county of McHenry and the state of Illinois (hereinafter referred to as the “District”), investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workers in the locality of the District employed in performing construction of public works, for the District.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE MCHENRY COUNTY CONSERVATION DISTRICT:

SECTION 1. To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the state, county, city, or any public body of any political subdivision or by any one under contract for public works,” approved June 26, 1941, as amended, the general

prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in the construction of public works coming under the jurisdiction of the District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the McHenry County, Illinois, area as determined by the Department of Labor of the State of Illinois last posted for July 1, 2015, that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's July 2015 determination and apply to any and all public works construction undertaken by the District. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the District to the extent required by the aforesaid Act.

SECTION 3. The Secretary of the Board of Trustees of the District shall publicly post or keep available for inspection by any interested party in the main office of the District this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4. The District shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose

wages will be affected by such rates.

SECTION 5. The Secretary of the Board of Trustees of the District shall promptly cause to file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

SECTION 6. The Secretary of the Board of Trustees of the District shall cause to be published in a newspaper of general circulation within the area an official notice of this Ordinance and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
