RESOLUTION #14-25**

**DESIGNATION DEPOSITORIES FOR FUNDS AND OTHER PUBLIC MONIES IN THE  
CUSTODY OF THE MCHENRY COUNTY CONSERVATION DISTRICT**

**WHEREAS**, the investment of Conservation District funds is governed by the Illinois Conservation District Act, 70 ILCS 410 *et seq.*, and the Illinois Public Funds Investment Act, 30 ILCS 235/1 *et seq.*; and

**WHEREAS**, Section 7 of the Conservation District Act, 70 ILCS 410/7, calls for the designation of depositories for funds and other public monies in the custody of the McHenry County Conservation District and sets certain requirements to be followed by financial institutions so designated; and

**WHEREAS**, the Chief Financial Officer (Director of Administration & Finance) of the McHenry County Conservation District requests this Board of Trustees to designate banks or other financial institutions in which the funds and monies of the District may be deposited; and

**WHEREAS**, the District may elect to place deposits in brokered investments, as authorized by the Board of Trustees and as allowed under the Illinois Public Funds Investment Act, 30 ILCS 235/1 *et seq.*; and

**WHEREAS**, such brokered investments, may be deposited through the authorized investment broker, with financial institutions not specifically enumerated below; and

**WHEREAS**, the Conservation District will ascertain copies (which may be in a digital format) of the most recent financial statements of the financial institutions where deposits are placed (hereinafter enumerated) as required by the Public Funds Investment Act;

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Trustees of the McHenry County Conservation District, McHenry County, Illinois that the following named banks and other financial institutions are hereby designated as depositories for funds and other public monies in the custody of the McHenry County Conservation District.
