

**MCHENRY COUNTY CONSERVATION DISTRICT  
RESOLUTION #19-47**

**AUTHORIZE THE CORRECTION OF A SCRIVENER'S ERROR IN THE EXECUTION AND  
RATIFICATION OF A LABOR AGREEMENT BETWEEN THE INTERNATIONAL UNION OF  
OPERATING ENGINEERS,  
LOCAL 150, PUBLIC EMPLOYEES DIVISION AND  
THE MCHENRY COUNTY CONSERVATION DISTRICT**

**WHEREAS**, the Board of Trustees of the McHenry County Conservation District (hereinafter referred to as the "District") desires to execute a Labor Agreement with the International Union of Operating Engineers, Local 150, Public Employees Division (hereinafter referred to as the "Labor Council") which is effective April 1, 2019 through March 31, 2022; and,

**WHEREAS**, the Board of Trustees did adopt Resolution #19-45 authorizing the execution and ratification of a Labor Agreement between the International Union of Operating Engineers, Local 150, Public Employees Division and the McHenry County Conservation District on July 18, 2019; and

**WHEREAS**, the Board Summary and the related motion on the agenda of July 18, 2019 had a scrivener's error as to the end date of the contract of March 30, 2021 instead of the correct date of March 31, 2022; and

**WHEREAS**, it is the purpose of this Agreement and it is the intent of the parties hereto to establish and promote a mutual harmonious understanding and relationship between the District and the Labor Council, to promote departmental efficiency and effectiveness, to negotiate changes in wages, certain benefits and polices and conditions of employment of employees covered by this Agreement, and to provide for the equitable and peaceful adjustment and resolution of differences which may arise from time to time over the interpretation and application of this Agreement; and

**WHEREAS**, both parties have reached agreement and a copy of said Agreement is already attached to Resolution #19-45 as "Exhibit A".

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Trustees of the District that it is necessary, desirable, and in the best interest of the District to amend the approval and ratification the attached Labor Agreement, and the President and Secretary of the Board of Trustees are hereby authorized to execute this resolution and the Executive Director is authorized to execute said Agreement which is effective April 1, 2019 and continues to March 31, 2022.
