APPROVING THE RECLASSIFICATION OF THE POSITION
OF DIRECTOR OF MARKETING AND EDUCATION FROM GRADE 21 TO GRADE 24
EFFECTIVE APRIL 1, 2020

WHEREAS, the McHenry County Conservation District (hereinafter referred to as the "District"), is a conservation district organized and existing under the laws of the State of Illinois (70 ILCS 410); and

WHEREAS, the job description for the position of Director of Marketing and Education was changed to reflect the addition of the oversight of the Education Services Department in October 2019; and

WHEREAS, the District is empowered to enter take such other actions as may be necessary for the proper conduct of its affairs (70 ILCS 410/12); and

WHEREAS, the parties hereto have determined that it is in the best interest of the District to change the Salary Grade 21 to Salary Grade 24 on the Administrative Scale as presented.

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the District that it is necessary, desirable, and in the best interest of the District to change the Administrative Pay Grade Level of the Director of Marketing and Education from a Grade 21 to Grade 24 as presented, and the President and Secretary of the Board of Trustees are hereby authorized to execute this resolution and any documents necessary to execute the intent of this resolution.
