EFFECTIVE APRIL 1, 2020

WHEREAS, the McHenry County Conservation District (hereinafter referred to as the "District"), is a conservation district organized and existing under the laws of the State of Illinois (70 ILCS 410); and

WHEREAS, the job description for the position of Land Preservation Manager has been changed to reflect the actual scope of work now being done and includes a title change; and

WHEREAS, the District is empowered to enter take such other actions as may be necessary for the proper conduct of its affairs (70 ILCS 410/12); and

WHEREAS, the parties hereto have determined that it is in the best interest of the District to change the title of Land Preservation Manager to Land Administration and Preservation Manager and amend the job description as presented.

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the District that it is necessary, desirable, and in the best interest of the District to change the title of Land Preservation Manager to Land Administration and Preservation Manager, amend the job description as presented, and the President and Secretary of the Board of Trustees are hereby authorized to execute this resolution and any documents necessary to execute the intent of this resolution.
