BETWEEN THE MCHENRY COUNTY CONSERVATION DISTRICT
AND AMERIGAS PROPANE GP, LLC FOR THE PURCHASE OF
PROPANE FUEL FOR DISTRICT LOCATIONS
9/1/2020 THROUGH 8/31/2021

WHEREAS, the McHenry County Conservation District (hereinafter referred to as the "District"), is a conservation district organized and existing under the laws of the State of Illinois (70 ILCS 410); and

WHEREAS, Amerigas Propane GP, LLC with local offices in Gurnee, IL (hereinafter referred to as the "the Contractor") is a for profit corporation out of Pennsylvania; and

WHEREAS, the Contractor was the lowest responsible and responsive bidder for the project as specified on BID #0720.07.02; and

WHEREAS, the District is empowered to enter into contracts and take such other actions as may be necessary for the proper conduct of its affairs (70 ILCS 410/12) ; and

WHEREAS, the parties hereto have determined that it is in the best interest of the District and the public for the entities to cooperatively coordinate the implementation of the purchase as outlined in the contract as presented to the Board and which is attached and made a part of the related project Bid files.

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the District that it is necessary, desirable, and in the best interest of the District to execute the Contract, and the President and Secretary of the Board of Trustees are hereby authorized to execute this resolution and the Executive Director or her designee is authorized to execute said Contract and other necessary documents to execute the intent of this resolution.





Any such contradictory or inconsistent terms or conditions shall be deemed objected to by Owner without further notice of objection and shall be of no effect nor in any circumstances binding upon Owner unless accepted by Owner in a written document plainly labeled, "Amendment to Contract/Bid." Acceptance or rejection by Owner of any such contradictory or inconsistent terms or conditions shall not constitute acceptance of any other contradictory or inconsistent terms or conditions.
