

MCHENRY COUNTY CONSERVATION DISTRICT
RESOLUTION #21-25

AWARDING A CONTRACT TO RED BUFFALO NURSERY OF RICHMOND, IL, THREE HERBICIDE LABOR PROJECTS AT \$45.85 PER HOUR AT ALDEN GAP, HARTS ROAD FEN AND GOOSE LAKE ESKERS FOR A COST NOT TO EXCEED \$23,000; AWARDING A CONTRACT TO BAXTER AND WOODMAN NATURAL RESOURCES, LLC OF CRYSTAL LAKE, IL, TWO HERBICIDE LABOR PROJECTS AT \$49.20 PER HOUR AT KISHWAUKEE CORRIDOR AND \$48.85 PER HOUR AT CORAL WOODS FOR A COST NOT TO EXCEED \$25,000; AND AWARDING A CONTRACT TO APPLIED ECOLOGICAL SERVICES, INC. OF WEST DUNDEE, IL, TWO HERBICIDE LABOR PROJECTS AT \$49.00 PER HOUR AT LAKE ELIZABETH AND SCHOOL SPRINGS FOR A COST NOT TO EXCEED \$40,000 (BID #0321.08.02)

WHEREAS, the McHenry County Conservation District (hereinafter referred to as the "District"), is a conservation district organized and existing under the laws of the State of Illinois (70 ILCS 410); and

WHEREAS, Red Buffalo Nursery of Richmond, IL; Baxter and Woodman Natural Resources, LLC of Crystal Lake, IL; and Applied Ecological Services, Inc. of West Dundee, IL (hereinafter referred to as the "the Contractors"); and

WHEREAS, the Contractors are the lowest responsible and responsive bidders for the project as specified on BID# 0321.08.02; and

WHEREAS, the District is empowered to enter into contracts and take such other actions as may be necessary for the proper conduct of its affairs (70 ILCS 410/12); and

WHEREAS, the parties hereto have determined that it is in the best interest of the District and the public for the entities to cooperatively coordinate the implementation of the purchase as outlined in the contract as presented to the Board and which is attached and made a part of the related project Bid files.

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the District that it is necessary, desirable, and in the best interest of the District to execute the Contract, and the President and Secretary of the Board of Trustees are hereby authorized to execute this resolution and the Executive Director or her designee is authorized to execute said Contract and other necessary documents to execute the intent of this resolution.




